- Our impact totaled \$265 million in community benefit in FY22. That number includes \$201 million in charity care as well as the unpaid costs of Medicaid. - We see health equity as a destination, and every day we progress in our journey to reduce health disparities by ensuring our workforce not only reflects, but also lifts up, everyone in our communities.

### Community Benefit is reported in two main categories:

**Access to Care through Financial Assistance - \$203.1M (76.5%) of our total FY22 Community Benefit Investment, including:**

› **\$43.3M (16.3%) - Unpaid Cost of Uninsured & Underinsured**  
Financial assistance to 190,727 people who were uninsured or underinsured and could not afford to pay for health care services.

› **\$159.8M (60.2%) - Unpaid Cost of Medicaid**  
The unreimbursed cost of serving 235,764 Medicaid patients.

**Broader Community Health - \$62.2M (23.5%) of our total FY22 Community Benefit was invested in internal and external services, programs and partner organizations to improve community health, including:**

› **\$30.3M - Health Professions Education**  
Staff time investing in future health care professionals, such as precepting residents and student nurses.

› **\$5.5M - Community Health Improvement Services**  
Investment in programs and partnerships to provide health education and to improve the overall health of the community.

› **\$23M - Subsidized Health Services**  
Clinical programs that provide access to care, despite operating at a loss because they meet an identified community need, such as rural emergency departments, clinics and home health.

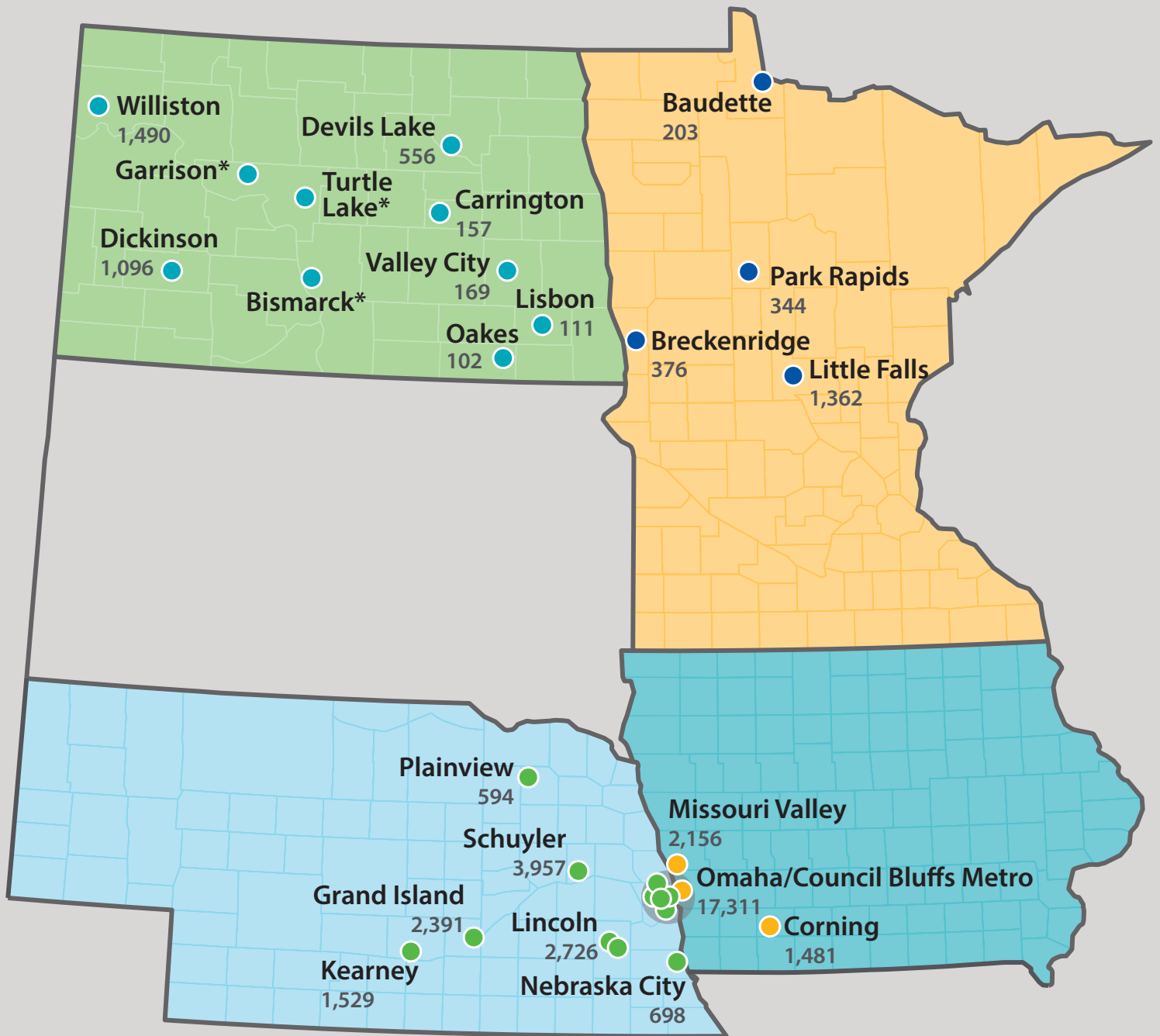
› **\$2.4M - Financial and In-Kind Contributions**  
Investments in community groups and other not-for-profit organizations with a focus on meeting identified community health needs.

› **\$0.8M - Community Building Activities and Community Benefit Operations**  
Funding of proven coalitions and operations that build capacity to address the root causes of health problems.

› **\$0.2M - Research**  
Investment in clinical research that is shared with the public.

Provided **548 victims** of sexual assault and intimate partner violence with care delivered by specially trained Forensic Nurse Examiners and connected them with community advocates. Sixteen survivors of human trafficking were positively identified and treated.



**Housing**

**140 patients** were referred to an onsite housing case manager to prevent eviction and/or find a safe housing placement upon discharge.  
**82 patients** patients accepted assistance and received services.



**Social Determinants of Health**

Through the Community Link program, **2,561** patients received education, assistance applying for safety net services and health insurance, as well as referrals to community-based organizations for transportation, food and housing.

To improve access to care, we extended primary care clinic hours and added two primary care physicians to our rural health clinic plus a Physician Assistant dedicated to hospital work. In FY23, we'll add four clinics to our speciality clinic (currently 24 clinics). We recruited and retained nurses for OB, inpatient, specialty and infusion programs, plus radiology and laboratory staff. We are proud of our \$1 million HRSA opioid grant which expands addiction treatment with a local facility, provider education and state-level discussions on prescribing laws.

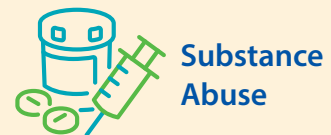
